# MST30719 Certificate III in Dry Cleaning Operations

#### Introduction

LDCT Laundry Dry Cleaning Training is a Registered Training Organisation 45491 registered with the Australian Skills Quality Authority. LDCT Laundry Dry Cleaning Training is proud to offer the MST30719 Certificate III in Dry Cleaning Operations and as a 24 month traineeship. The program involves both scheduled classroom learning activities and workplace-based training and assessment. This program provides learners with skills and knowledge required to safely work in a dry cleaning operation. This includes, fibres and fabrics, customer service receiving and sorting, spotting, pressing, dry cleaning, wet cleaning, safe handling of solvents and chemicals, WHS, quality and all aspects of a dry cleaning operation.

This qualification reflects the role of dry cleaning workers in a range of settings from a high street dry cleaner to high end dry cleaning, hospitality, Casino's, health care, PPE (fire uniforms) uniform suppliers, theme parks, cruise ships, hat makers and industrial dry cleaning of gloves and wool. Students will learn about the dry cleaning industry, how it operates and multitasking across the various areas of the operations. Students will also learn the process within the dry cleaners and how they all tie together to ensure production flows and provides a quality product for our clients. This course also provides an excellent understanding of the DIA Code of Practice for the safe handling of solvents. The skills and knowledge learnt in this training will provide a pathway to working in any dry cleaner across the globe.

# Who is responsible for your training?

LDCT Laundry Dry Cleaning Training is responsible under the National Vocational Education and Training Regulator Act 2011 for the quality of the training and assessment being delivered in this course and for the issuance of all AQF certificates.

# **Units of Competency**

The MST30719 Certificate III in Dry Cleaning Operations comprises 19 units of competency. LDCT Laundry Dry Cleaning Training have organised these units of competency into relevant units and clusters relating to shared skills and knowledge or shared work tasks. This results in an efficient delivery of training and assessment and a structure that is very logical for learners.

- To be issued the MST30719 Certificate III in Dry Cleaning Operations qualification a learner must be assessed as competent in 19 units of competency. These units of competency are comprised of 9 core units and 10 elective units.
- LDCT Laundry Dry Cleaning Training have selected the elective units of competency within this
  course and have chosen these based on providing the learner a broad set of skills with a
  focus on providing specialised dry cleaning knowledge which reflects the roles of those who
  perform supervision roles, specialised technical tasks or multi-skilled roles within a dry-cleaning
  environment.
- Facilitating compliance, production flow and leadership. The selected units of competency are also supported by the learning content within the operational flow of the dry-cleaning process.

The selection of these units of competency and the course structure has been confirmed through industry engagement undertaken by LDCT Laundry Dry Cleaning Training.

# **National recognition**

These competencies have been drawn from the nationally endorsed industry training package the Textile Clothing and Footwear Training Package (MST). On successfully completing the training and assessment, the MST30719 Certificate III in Dry Cleaning Operations will be issued. A transcript listing all units of competency will also be issued. The qualification and units of competency are nationally recognised and provide individuals with a valuable qualification that can be applied throughout Australia and the whole of the laundry industry. LDCT Laundry Dry Cleaning Training will issue a qualification within 30 days of the final assessment being completed

## **Program outline**

Training is delivered in a blended mode, classroom-based, delivery on the job (one day per month) which is trainer led combined with self-paced learning (a minimum of 3 hours per week) and workplace learning as an employee. Written learning activities will reinforce theoretical knowledge, and skills will be practiced in the workplace where learning will be placed into context. Visits by LDCT Laundry Dry Cleaning Training trainers to the student's workplace will be undertaken once per month as per an agreed schedule (6-8 hours). In between visits a scheduled phone or skype session (as per agreed schedule) will be held to ensure ongoing support and assistance with self-paced knowledge and tasks. Regional, rural and Interstate training may take place in blocks. The primary purpose of workplace visits is to deliver the underpinning knowledge and undertake assessment and collect workplace evidence. The course modules (clusters) are sequenced in a way that allows a logical progression in line with the production flow of a dry cleaning business from the counter to dispatch. Participants will be provided with professionally presented reference material to assist them to develop their knowledge of the subject included will also be a copy of the DIA Code of Practice for the safe handling of solvent.

#### Locations

Classroom training and practical skills training will be delivered at the following locations:

- Classroom Training Site: Workplace or Training School
- Practical Training Site: Workplace or Training School





## **Expected duration**

The program is designed to be delivered over 18 months. LDCT Laundry Dry Cleaning Training can support participants that need additional time. Alternatively, participants who have pre-existing skills and knowledge may be able to complete the course in a shorter duration.

# **Assessment requirements**

The assessment is conducted using a combination of realistic workplace tasks, projects, knowledge tests, response to case studies and feedback from supervisors. The following provides a brief explanation of the assessment methods that are to be applied:

#### Observation/Demonstration/Verbal Questions.

The student is required to demonstrate a range of skills whilst being observed by, or interacting and answering questions with, the assessor. These activities will be clearly explained and always relate to duties relevant to the workplace. These activities allow the assessor to observe the student apply their knowledge and skills during practical activity.

#### Assessment tasks / Written Questions.

The student is required to complete a range of written questions and answers as part of their assessment within the classroom environment with the assessor

#### Portfolio of Evidence.

The portfolio of evidence is a combination of evidence form the learner and the workplace supervisor. The learner will be required to keep a journal of worktime, study and training time, self-paced study time and on the job learning. The workplace supervisors will be asked to provide feedback about the student's performance though a workplace supervisor report during a module. The supervisor will receive a briefing at the time the student begins studying each module to inform them of the module requirements.

#### Practical (on the job)

Students in the Certificate III in Dry Cleaning Operations are required to be full time employees to be able to complete if enrolled as a trainee. Students who are existing worker may be either part time or full time employees. LDCT Laundry Dry Cleaning Training will engage with the nominated workplace to ensure that it will provide a suitable environment to gather practical experience across all tasks outlined in the units of competency. LDCT Laundry Dry Cleaning Training will need to establish a formal training Agreement with the nominated workplace.





LDCT Laundry Dry Cleaning Training also require a minimum level of supervision for students, a safe working environment and will need to undertake regular schedule training visits to the workplace to undertake practical assessment of the student performing dry cleaning tasks.

### **Entry requirements**

There are no specified entry requirements for this qualification specified within the Industry Training Package.

Noting this, LDCT Laundry Dry Cleaning Training requires persons who undertake this course to:

- Be aged 18 years or over.
- Have suitable language, literacy and numeracy skills to read and comprehend learning materials and perform tasks related to performing tasks to all areas of the dry cleaning process, maintaining compliance to the DIA Code of Practice, interpreting workplace policy and procedure, reporting hazards providing customer service, classifying of cleaning requirements, operating dry cleaning and wet cleaning technology, spotting, pressing, dispatch, sustainability and quality.

**Please note.** LDCT Laundry Dry Cleaning Training will engage with persons expressing interest in enrolment to discuss their language, literacy and numeracy skills. LDCT Laundry Dry Cleaning Training can provide additional learning support to students who require basic assistance. For students who have more fundamental support needs, LDCT Laundry Dry Cleaning Training can refer these students to a specialist language, literacy and numeracy development provider who can assist students to improve their language, literacy and numeracy skills to enable them to suitably commence the course.

#### **Recognition of Prior Learning**

Applicants can apply for recognition of their existing skills and knowledge that are relevant to the units of competency within the program. These skills and knowledge may have been obtained through workplace training or experience and may reduce the number of units required to be completed during the program. Students are encouraged to notify LDCT Laundry Dry Cleaning Training of their interest or intention to apply for RPL prior to their enrolment. We will provide you a pre-training review questionnaire that gathers information about your prior experience. This information is then used to determine the best pathway for you to achieve competency.
